On December 17, 2024 the Linn County Board of Commissioners approved Resolution & Order 2024-414 for Construction Manager / General Contractor Services for the Linn County Jail Renovation. Included in this R&O was the authorization for publication and advertisement of the RFP the Board also approved. This publication and advertisement were released the same day to the Sheriff's Office website, and over subsequent days in trade journals, websites, and the Daily Journal of Commerce (online) on December 20th, 2024.

Upon review of the submitted proposals, and scoring, by a committee, Linn County intends to negotiate and award a contract to the firm receiving the top score in the RFP process – Gerding Builders, 200 SW Airport Ave, Corvallis, Oregon 97333 – upon authorization of the Linn County Board of Commissioners and expiration of the seven day protest period. At any time prior to the issuance of a valid contract, this RFP may be cancelled and proposals may be rejected in accordance with the RFP, ORS, and Linn County Code.

This Notice of Intent to Award is issued pursuant to ORS 279B.135 and LCC 137-047-0610. Any entity which believes that they are adversely affected or aggrieved by the award may submit a written protest within seven (7) calendar days after the issuance of this Notice. Protests submitted after that date will not be considered. All protests must be addressed as follows:

A written protest must include, at minimum, the following information:

- A detailed statement of the legal and factual grounds for the protest;
- A description of the resulting prejudice to the offeror; and
- A statement of the desired changes to the contract terms and conditions, including any specifications.

If a protest is not settled, the Board of Commissioners, or its designee, shall promptly issue a written decision on the protest. Judicial review of that decision will be available if provided by statute.
